



Acknowledgement & Indemnity Form
MOTORSPORT IS DANGEROUS PLEASE READ THIS FORM CAREFULLY

1. I, the undersigned, agree that I will not participate in the Activity, described below, arranged or provided by Ice Driver Limited unless I have first attended a safety briefing with Ice Driver Limited or its nominated agent at which I will be advised of the inherent risks involved in participation in the Activity. Following the briefing, I will abstain from participating in the Activity should I not agree to accept the inherent risks involved.
- 2 I warrant that:
 - 2.1 I am in good physical and mental health, my eyesight (as corrected as appropriate) is up to the standard required for a road driving test in the UK and I am not suffering from any medical condition or disability which might make it unsafe for me to participate in the Activity;
 - 2.2 I do not suffer from epilepsy, fits, recurrent blackouts, fainting spells or giddiness, any form of psychiatric or mental illness or any other pre-existing condition that might make it unsafe for me to participate in the Activity;
 - 2.3 I am not participating in the Activity against medical advice;
 - 2.4 I am over the age of eighteen years of age and currently hold and have held a full driving licence for a manual transmission passenger road vehicle for at least one year prior to the date of the Activity and that my licence is valid for use within the European Union;
 - 2.5 I am fluent in the English language and agree that all instructions that I receive from Ice Driver Limited or its nominated agents will be in English.
- 3 I agree to notify Ice Driver Limited or its nominated agent immediately in the event that I feel physically or mentally unwell or am suffering from an injury of any description during the course of Activity and will immediately discontinue the Activity if Ice Driver Limited or its nominated agent considers that such physical or mental condition is likely to result in personal injury or damage to property.
- 4 I agree not to participate in the Activity whilst under the influence of alcohol or intoxicating drugs (prescribed or otherwise) that will or are likely to impair my ability to take part.
- 5 I acknowledge that failure to comply with any reasonable guidance or instruction, regarding the Activity, from Ice Driver Limited or its nominated agent will result in an immediate cessation of the Activity and Ice Driver Limited will be deemed to have discharged its obligations to provide the same.
- 6 I acknowledge that the Activity is not without risk and that I undertake to look after myself and those around me in a careful and thoughtful manner at all times whilst participating in the Activity and/or whilst at any location at which an Activity is provided.
- 7 I acknowledge that Ice Driver Limited reserves the right to remove me or anyone accompanying me from the location at which any Activity is being provided at any time if, in the sole discretion of Ice Driver Limited or its nominated agent, my actions or those of my companion(s) to be dangerous or detrimental to others.
8. I understand that not every driver can adapt to every vehicle due to differing handling characteristics. If Ice Driver Limited or its nominated agent consider that any Activity may be compromised Ice Driver Limited and/or its nominated agent may order changes to any vehicle that I will be driving. I understand that safety is paramount and the decision of Ice Driver Limited or its authorised agent is final.

Indemnity

I hereby agree to indemnify and hold harmless, Ice Driver Limited, its employees, officers and agents against all direct and indirect losses, liabilities, costs (including but not limited to legal and other professional costs), charges, expenses, actions, procedures, claims, demands and damages (including but not limited to the amount of damages awarded by a court of competent jurisdiction) that they may face arising directly or indirectly from my conduct or participation in the Activity, to the extent that the same do not arise directly from the negligence, or wilful default of Ice Driver Limited.
10. The warranties, terms, conditions and indemnities contained within this document and any non-contractual obligations arising from the Activity shall be governed by English law and the parties submit to the exclusive jurisdiction of the English courts.
11. I agree to abide by the Contract governing the purchase of my Activity and Ice Driver Limited's standard terms and conditions, and they are hereby incorporated into this Acknowledgement and Indemnity Form. In the event of any conflict of terms, this Acknowledgement and Indemnity Form shall take precedence over the Order and any other documents.
